SCOPE OF THIS PRIVACY POLICY

- 3. This privacy policy applies only to the actions of Dr. Christian Pintado and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

DATA THAT IS GIVEN TO US BY YOU
